The Fund may also invest in Nigerian real estate and real estate securities.

The Fund offers exposure to multiple asset classes and aims to reduce investment risk by diversifying across these asset classes, making it an ideal core holding.

Monthly Comments

Fund and market review

Nigerian equities rebounded for another month in March despite the apparent bearish sentiment clouding equity markets over the month. The Nigerian Stock Exchange All Share Index (NSEASI) rose 3.0% over the month to end Q1 2015 down 11.6%. The Fund however rose 0.5% in the same period, lagging the market return and also the benchmark return of 1.3% for the month.

Positive performance in the Fund was largely driven by the 18.4% gain in Dangote Cement over the month, spurred on by their relatively strong 2015 results. Despite the high yields to be had in the equity market, negative sentiment stemming from the uninspiring results from Nigerian companies weighed. As such, despite the fact that many stocks had dividend yields considerably above fixed income instruments, investors focused on the underlying performance of companies. Weakening consumer demand meant that companies struggled to grow revenues and the declining exchange rate put pressure on costs. Profits on average declined in 2015 in response to macro pressures. The Fund Manager continued to cautiously increase the Fund's equity weighting by increasing exposure to a few quality names in the Banking and Industrial sectors of the market, purchasing them at depressed prices.

Fixed income yields rose and the yield curve flattened over the month as yields on the short end of the curve rose more than those at the longer end of the curve. The Monetary Policy Committee (MPC) unexpectedly tightened policy by increasing the policy rate by 1.0% to 12.0%. This was in response to the 11.4% inflation figure for February. In response to rising yields, the Fund manager continued to focus on the short to mid end of the curve to maintain flexibility.

Fund and market outlook

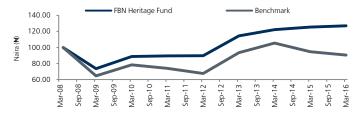
We believe equity prices may remain under pressure due to the weak macro outlook and the resulting weakness in companies prospects. In the fixed income space, we will favour short to medium tenors in order to take advantage of the expected yield rise following the tightening of the MPC's stance.
