Executive Summary

- The World Bank downgraded the global growth forecast for 2022 to 3.2% from 4.1%, citing the pressure that Russia's invasion of Ukraine has placed on the global economy. Similarly, the International Monetary Fund (IMF) cut its global growth forecast, projecting a 3.6% GDP growth rate for the global economy this year and for 2023, this is about an 80bps and 20bps drop respectively from its forecasts published in January. According to the IMF, the Ukrainian and Russian economies are expected to contract by 35% and 8.5% respectively in 2022. They added that the loss of life, destruction of physical capital, and flight of citizens will severely impede economic activity for many years to come.
- April was a bad month for global stocks as prices plummeted and major indices recorded their worst performance in years. Stocks slumped anew in volatile April trade, marked by large daily and intraday swings, with investors hand-wringing over rising interest rates, relentless inflation, corporate earnings, and global unrest. The Dow Jones Industrial Average (DJIA), S&P 500, NASDAQ Composite and Russell 2000 all shed 4.91%, 8.80%, 13.37% and 9.95% respectively in April, bringing their year to date (YtD) return to -9.25%, -13.31%, -21.23% and -16.98%. It was the biggest monthly percentage declines since March 2020 for the Dow and S&P 500, and the largest for the Nasdaq since October 2008. This was the same in other markets as well with the FTSE 100 shedding 3.90%, CAC (-6.61%), Japan Nikkei (-9.48%) and the DAX (-8.00%).
- Nigeria's headline inflation rate rose for the second consecutive month at 15.92% in March 2022, from 15.70% in February 2022. This represents the highest rate recorded since October 2021. Food inflation rose to 17.20%, 9bps higher than the 17.11% recorded in the preceding month. On the other hand, the core inflation rate dropped to 13.91% in March from 14.01% recorded in February 2022.

Outlook

- Concerns over geopolitics, the global macro economy and monetary policy remain at the top of investors' minds. Unusually high uncertainty surrounds global outlook as downside risks dominate a possible worsening of the war, escalation of sanctions on Russia, a sharper-than-anticipated deceleration in China growth due to the re-emergence of COVID etc. While a gradual resolution of supply-demand imbalances is expected in the baseline, risks are still tilted to the upside.
- Equities (NGN) Unlike its regional peers and the global market, the Nigerian bourse has remained bullish with stock prices hitting year
 highs. The market currently trades at a price to earnings ratio (P/E) of 10.5x, well above its peers (Ghana- 6.9x, Egypt 7.9x, Kenya- 8.2x)
 with the All-share index also crossing 50,000pts. These suggest that the market might be over-valued, and correction might be on the
 horizon.
- Fixed Income (NGN) As stated in our last factsheet, we expect lower inflows into the market this second quarter, therefore interbank rates will continue to swing between single and double digit levels based on banks' funding obligations. In May, we expect lesser coupons of NGN23.49bn and NTB maturities of NGN280.50bn.
- Eurobonds As projected, the positive momentum seen last month was not sustained as the SSA Eurobonds market went back to its bearish state. With the Fed further hiking rates coupled with existing risk factors, we posit that yields might still go higher in the coming period which on one hand, presents entry point for potential investors.

Terms and Conditions
